My Instant Interview takes your privacy seriously. Please read the following to learn more about our privacy policy.

What This Privacy Policy Covers

- * This policy covers how My Instant Interview treats personal information that My Instant Interview collects and receives, including information related to your past use of My Instant Interview products and services. Personal information is information about you that is personally identifiable like your name, address, email address, or phone number, and that is not otherwise publicly available.
- * This policy does not apply to the practices of companies that My Instant Interview does not own or control, or to people that My Instant Interview does not employ or manage.
- * My Instant Interview adheres to the Safe Harbor program developed by the U.S. Department of Commerce and the European Union. My Instant Interview regularly reviews its compliance with this Privacy Policy. When we receive formal written complaints, it is our policy to contact the complaining user regarding his or her concerns. We will cooperate with the appropriate regulatory authorities, including local data protection authorities, to resolve any complaints regarding the transfer of personal data that cannot be resolved between My Instant Interview and an individual.

Information Collection and Use

General

- * My Instant Interview collects personal information when you register with My Instant Interview, when you use My Instant Interview products or services, when you visit My Instant Interview pages or the pages of certain My Instant Interview partners.
- * When you register we ask for information such as your name and email address.
- * My Instant Interview automatically receives and records information on our server logs from your browser, including your IP address, My Instant Interview cookie information, and the page you request.
- * My Instant Interview uses information for the following general purposes: to customize the content you see, fulfill your requests for products and services, improve our services, contact you, conduct research, and provide anonymous reporting for internal and external clients.

Children

- * My Instant Interview does not contact children under age 13 about special offers or for marketing purposes.

* My Instant Interview does not ask a child under age 13 for more personal information, as a condition of participation, than is reasonably necessary to participate in a given activity or promotion.

Information Sharing and Disclosure

* My Instant Interview does not rent, sell, or share personal information about you with other people or non-affiliated companies except to provide products or services you've requested, when we have your permission, or under the following circumstances:

* We provide the information to trusted partners who work on behalf of or with My Instant Interview under confidentiality agreements.

* We respond to subpoenas, court orders, or legal process, or to establish or exercise our legal rights or defend against legal claims.

* We believe it is necessary to share information in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of My Instant Interview 's terms of use, or as otherwise required by law.

* We transfer information about you if My Instant Interview is acquired by or merged with another company. In this event, My Instant Interview will notify you before information about you is transferred and becomes subject to a different privacy policy.

Cookies

* My Instant Interview may set and access My Instant Interview cookies on your computer.

Your Ability to Edit and Delete Your Account Information and Preferences

General

* If you need to edit or delete your account, send an email from the email address you registered with to admin@myinstantinterview.com. Your information may still remain on our back-up storage and server logs for some period of time.

Confidentiality and Security

* We limit access to personal information about you to employees who we believe reasonably need to come into contact with that information to provide products or services to you or in order to do their jobs.

* We have physical, electronic, and procedural safeguards that comply with federal regulations to protect personal information about you.

Changes to this Privacy Policy

* My Instant Interview may update this policy. We will notify you about significant changes in

the way we treat personal information by sending a notice to the primary email address specified in your My Instant Interview account or by placing a prominent notice on our site.
